About Permissions for People

There are several permissions that control access to features and functionality associated with people. These permissions are grouped into two sections.

People Section

Permissions that are grouped in the *People* section control access to features and functionality in the PEOPLE area of Unite. The following table provides a description for each permission.

| Permission | Description |
|----------------------------|---|
| Search | Access to Search People (Prospects and Applicants) |
| Add Record | Add People (Prospects or Applicants) |
| Actions-Send Communication | Send Email to Selected Applications |
| Actions-Edit | Edit Selected Data in Groups (Formerly Batch Edit) |
| Actions-Add Fee Waiver | Create Application Fee Waivers for Selected Records |
| Actions-Promote Deferral | Create New Application for Selected Records |
| Actions-Archive | Archive Selected Records |
| Actions-Delete | Delete Selected Records |

Person Details Section

Permissions that are grouped in the *Person Details* section control access to features and functionality on the person record in Unite. The following table provides a description for each permission.
