#### **About Starter User Roles**

To help you get started with role-based security, LSAC created five "starter" user roles. The starter user roles are configured with permissions that represent different job functions within a law school admissions office. You cannot delete the starter user roles. However, you can edit the roles to better align with your needs. This includes changing the role name and configuring different permissions. The following table provides a description of the five starter roles.

Starter Role	Description
Operations	This role generally is assigned to a permanent employee in your admissions office who could be responsible for performing day-to-day functions in Unite.
Primary User	This role generally is assigned to a permanent employee in your admissions office who could be responsible for supervising other Unite users.
Reviewer	This role generally is assigned to someone who may not work in your admissions office but could be responsible for evaluating applications and submitting recommendations in Unite.
Student Worker	This role generally is assigned to a temporary or seasonal worker who could be responsible for performing data entry functions in Unite.
Super User	This role is assigned to a user who understands how Unite interfaces with other school systems and could be responsible for setting up, configuring, and troubleshooting the system.

There are over 110 permissions in Unite. Permissions are grouped into nine expandable and collapsible sections. The following tables show permission configurations for each starter user role by section.
